"Global Economic Issues: What is Missing?" by
Mark Weisbrot, co-Director of the Center for Economic and
Policy Research, an independent, non-partisan think tank in
Washington, D.C. "Some of the most important economic issues
often receive little or no attention, or are misreported in the press.
For example, over the last 25 years there has been a dramatic
slowdown in economic growth in the vast majority of developing
countries. This is especially true for Latin America, where per
capita GDP has hardly grown at all since 1980. Also, opposing
sides on global economic issues are often seen as "free trade" vs.
"protectionism" or "free market" vs. state intervention; yet these
roles are often reversed, and most "free trade" agreements also
impose very costly forms of protectionism. Greater clarity on
these and other vital economic issues would greatly benefit both
policy-makers and the general public."

Friday, April 1: HOW TO COVER LABOR ISSUES

As multinationals continue to expand overseas, labor issues have become a major topic for journalists. The question of labor standards, as well as what responsibilities U.S. companies and their foreign subcontractors have abroad, has become increasingly explosive, as the widespread boycott of Nike and the controversies over Liz Claiborne and Exxon have shown.

The sessions on labor will include a briefing on the key issues and a discussion of some of the pitfalls of covering these complicated disputes.

9 am – 10:30 am The Key Issues: "Human Rights and Multinational

Corporations" with Mila Rosenthal, Director, Business and Human Rights Program, Amnesty International USA; Amy Hall, Social Consciousness Director, Eileen Fisher; and Ashwini Sukthankar, Director of Investigations and Research at Worker Rights Consortium.

The panel will address the legal and social human rights obligations of multinational companies. The focus will be on the apparel and footwear industries and the role of multinational companies in taking responsibility for labor conditions in their supply chains, including voluntary efforts by some U.S. companies to monitor labor conditions in their contracting factories.

Newsmaker lunch on "Making Globalization Work for All: Peace Security, and Environmental Sustainability" with Jeffrey Sachs, Director, Earth Institute at Columbia University; Quetelet Professor of Sustainable Development; a professor of health policy and management; and Special Advisor to UN Secretary General Kofi Annan.

The war in Iraq sidetracked the world from critical issues of poverty alleviation and environmental sustainability. The year 2005 is critical to getting back on track. In September 2005, world leaders will come to the United Nations to assess the results of the Millennium Declaration, and to find ways to get the Millennium Development Goals back to the forefront of public concern and attention. Prof. Sachs will discuss the prospects for a serious globally coordinated attack on extreme poverty, disease, and environmental degradation, and will discuss the shared responsibilities of the rich and poor countries and international institutions in such an effort.

Panel Discussion on "Covering the World Bank." Penetrating the bureaucracy of the World Bank is a vital part of covering global economic issues since the Bank is involved in everything from giving advice on privatization and banking rescues to providing assistance on trade and macroeconomic policy. Abid Aslam, who covered the World Bank for the Interpress News Service, will discuss how the Bank works and who reporters need to talk to get the right information. Toby McIntosh, a reporter for Freedominfo.org and managing editor, BNA Inc., Daily Report for Executives, will outline which documents the bank is legally obliged to disclose for the many different projects they are involved in around the world. Saturday, April 2: TRADE AND DEVELOPMENT

Trade has become an increasingly controversial subject. The demonstrations in Cancun in September, 2003 are only the latest manifestation of global dissatisfaction with current trade agreements. The aim of this session is to look at some of the most important topics of trade and development to see where the story is going. Reporters will also learn about the challenges facing countries with resource wealth.

The session on free trade will cover the basic issues and give reporters tips for what to look out for when assessing the trade agreements now on the negotiating table.
