Kaushik Basu, *Professor of Economics and International Studies, Cornell University*

Kaushik Basu is Professor of Economics and the Carl Marks Professor at Cornell University. From 2012 to 2016, he served as Chief Economist of the World Bank. Educated at St. Stephen's College, Delhi, and the London School of Economics, Basu has published extensively in development economics, game theory, welfare economics, and industrial organization. His most recent book, *The Republic of Beliefs: A New Approach to Law and Economics*, was published by Princeton University Press in 2018.

Clement Bohr, *Adjunct Assistant Professor, UCLA Anderson School of Management*

Clement Bohr is a macroeconomist whose research spans monetary economics, business cycles, and the structural and technological changes driving economic growth. At UCLA Anderson School of Management, he serves as Adjunct Assistant Professor in Global Economics and Management and as Senior Economist at the UCLA Anderson Forecast, where he directs the quarterly U.S. economic forecast. He completed his PhD in Economics at Northwestern University in 2024 and was a postdoctoral researcher with Joseph Stiglitz at Columbia Business School during 2024–2025.

Jason Bordoff, *Founding Director, Center on Global Energy Policy at Columbia University SIPA*

Jason Bordoff is the Founding Director of the Center on Global Energy Policy and Professor of Professional Practice at Columbia University's School of International and Public Affairs (SIPA). He also serves on the faculty of the Columbia Climate School, where he was Co-Founding Dean Emeritus. Previously, Bordoff was Special Assistant to President Obama and Senior Director for Energy and Climate Change on the National Security Council, and held senior policy roles in the White House's National Economic Council and Council on Environmental Quality. He is a leading expert on energy and climate policy, with research at the intersection of economics, energy, environment, and national security. Bordoff is a columnist for *Foreign Policy*, has written for *Foreign Affairs*, *The New York Times*, *Financial Times*, *The Economist*, and appears regularly on NPR, CNN, Bloomberg, and other outlets. He holds a BA magna cum laude from Brown University, an MLitt from Oxford University as a Marshall Scholar, and a JD with honors from Harvard Law School.

Winnie Byanyima, *Executive Director, UNAIDS; Under-Secretary-General, United Nations*

Winnie Byanyima is Executive Director of UNAIDS and an Under-Secretary-General of the United Nations. She leads global efforts to end AIDS as a public health threat by 2030 and co-chairs the People's Medicines

Alliance, advocating for equitable access to medicines. Previously, she served as Executive Director of Oxfam International and was elected three times to Uganda's parliament. A global leader on gender equality, she founded the Forum for Women in Democracy in Uganda and served on Prime Minister Trudeau's Gender Advisory Council during Canada's G7 Presidency. Byanyima holds an MSc in mechanical engineering from Cranfield University, an undergraduate degree in aeronautical engineering from the University of Manchester, and has received four honorary doctorates.

Jeronim Capaldo, *Senior Fellow, Boston University Global Development Policy Center*

Jeronim Capaldo is a senior economist at UNCTAD and a senior fellow at Boston University's GDP Center. His research focuses on the empirical linkages between macroeconomic policy, trade, industrial development, and inequality, with extensive work on the impacts of global trade expansion on employment, inequality, and development.

John Cassidy, *Staff Writer, The New Yorker*

John Cassidy has been a staff writer at *The New Yorker* since 1995, writing the regular column *The Financial Page* on economics and politics. He has covered topics from Keynes and Marx to globalization and the degrowth movement and is the author of *How Markets Fail* and *Dot.Con*. Cassidy grew up in Leeds, West Yorkshire, and holds degrees from Oxford, Columbia, and New York Universities. He lives in Brooklyn with his family and is currently working on a new book about capitalism and its critics.

Bruce Chapman, *Professor, Australian National University*

Bruce Chapman is Emeritus Professor of Economics at the Australian National University. He holds a PhD from Yale University and has authored over 300 publications on higher education financing, applied labor economics, and government risk management. Chapman designed the world's first national income-contingent student loan (ICL), implemented in Australia in 1989, which has influenced policies globally. His applied research extends ICL principles to energy financing, parental leave, fines collection, and war investment financing.

Giovanni Dosi, *Professor of Economics, Institute of Economics, Scuola Superiore Sant'Anna*

Giovanni Dosi is Professor of Economics at the Institute of Economics. He is continental Europe editor of *Industrial and Corporate Change* and is listed among ISI Highly Cited Researchers. Dosi is a corresponding member of the Accademia Nazionale dei Lincei in Italy and has received the Wiley TIM Distinguished Scholar Award and the Penrose Award for research on evolutionary economics. His books include *Innovation*,

Organization and Economic Dynamics (2000), *Economic Organization, Industrial Dynamics and Development* (2012), and *The Foundation of Complex Evolving Systems* (2023).

Bilge Erten, *Associate Professor of Economics and International Affairs, Northeastern University*

Bilge Erten is Associate Professor of Economics and International Affairs at Northeastern University. Her research focuses on development and international economics, particularly the effects of global integration policies on structural transformation and labor market adjustment in developing countries. Before joining Northeastern, she was a postdoctoral research scholar at Columbia University's Committee on Global Thought. She holds a PhD in Economics from the University of Massachusetts Amherst.

Rana Foroohar, *Global Business Columnist and Associate Editor, Financial Times*

Rana Foroohar is Global Business Columnist and Associate Editor at the *Financial Times* and CNN's global economic analyst. She is the author of *Makers and Takers* (shortlisted for the Financial Times McKinsey Book of the Year), *Don't Be Evil*, and *Homecoming: The Path to Prosperity in a Post-Global World*. Foroohar has received a SABEW award for tech and policy coverage, the Peter Weitz Prize for transatlantic reporting, and other honors. She previously worked at *TIME* and *Newsweek*, covering economics and foreign affairs, and serves on the advisory board of the Open Markets Institute. She graduated from Barnard College, Columbia University, and lives in Brooklyn with her husband and two children.

Kevin Gallagher, *Professor, Boston University; Director, Global Development Policy Center (GDPC)*

Kevin P. Gallagher is Professor of Global Development Policy at Boston University's Frederick S. Pardee School of Global Studies and Director of the Global Development Policy Center. He focuses on financial stability, human well-being, and environmental policy, serving as Lead Expert on Multilateral Development Bank Reform to the Brazilian G20 Presidency and co-chairing initiatives on climate, debt relief, and sustainable development. He has held advisory and leadership roles with the T20 India and Italy Task Forces, the United Nations, the US Department of State, and multiple universities worldwide. Gallagher has authored or co-authored seven books, including *The Case for New Bretton Woods* and *The China Triangle*, and specializes in economic development, trade and investment policy, international environmental policy, and Latin America.

Jayati Ghosh, *Professor of Economics, University of Massachusetts at Amherst*

Jayati Ghosh taught economics at Jawaharlal Nehru University for nearly 35 years and is currently Professor of Economics at the University of Massachusetts Amherst. She has authored or edited 20 books and over 200 scholarly articles and received numerous awards including the ILO Decent Work Research Prize (2011) and

the 2023 Galbraith Award for contributions to economics and humanity. Ghosh has advised governments and international organizations, served as Executive Secretary of International Development Economics Associates (2002–2021), and is a member of several UN advisory boards. She also writes regularly for mainstream media.

Ian Goldin, *Professor of Globalization and Development, University of Oxford*

Ian Goldin is Professor of Globalisation and Development at Oxford University and founding Director of the Oxford Martin School, leading 45 research programs with over 400 academics. He previously served as Vice President and Director of Policy at the World Bank, Chief Executive of the Development Bank of Southern Africa, and Economic Advisor to President Nelson Mandela. Goldin holds degrees from the University of Cape Town, London School of Economics, INSEAD, and the University of Oxford. He has published over 50 academic papers and 25 books, including *Age of the City* and *The Shortest History of Migration*, and presented BBC series on global economic issues. He is Chair of core-econ.org, a founding Director of the Center for Future Generations, and an honorary trustee of several charities.

Peter Goodman, *Global Economics Correspondent, The New York Times*

Peter S. Goodman is the global economics correspondent for *The New York Times*. Over three decades, he has reported from more than 50 countries on major economic transformations, including the 2008 financial crisis and China's rise as a global superpower. Goodman is a two-time Gerald Loeb award winner and the author of three books, including *How the World Ran Out of Everything* (2024) and the best-selling *Davos Man* (2022).

Bruce Greenwald, *Professor Emeritus, Columbia Business School*

Bruce C. N. Greenwald is the Robert Heilbrunn Professor Emeritus of Finance and Asset Management at Columbia Business School and Academic Director of the Heilbrunn Center for Graham & Dodd Investing. Described as “a guru to Wall Street’s gurus” by *The New York Times*, he is an authority on value investing, productivity, and the economics of information. Greenwald has received numerous teaching awards, including the Columbia University Presidential Teaching Award, and teaches popular courses on investing, strategic behavior, and globalization.

Martin Guzman, *Professor, Columbia University SIPA; Co-President, Initiative for Policy Dialogue*

Martin Guzman is Professor at Columbia University's School of International and Public Affairs and Professor of Money, Credit, and Banking at the National University of La Plata, Argentina. He served as Argentina's

Minister of Economy from 2019 to 2022 and is a leading expert on sovereign debt and crisis resolution. Guzmán co-leads the Initiative for Policy Dialogue at Columbia Business School, directing its Sovereign Debt Management and Restructuring Program. He is a member of the Pontifical Academy of Social Sciences, a Young Global Leader of the World Economic Forum, and a commissioner of the Independent Commission for the Reform of International Corporate Taxation (ICRICT). He holds a PhD in Economics from Brown University and a BA and MA from the National University of La Plata.

Robert Howse, *Professor of International Law, NYU School of Law*

Robert Howse is the Lloyd C. Nelson Professor of International Law at NYU School of Law, specializing in international economic law, trade, investment, and finance, as well as legal and political philosophy. He co-founded the New York City Area Working Group on International Economic Law and serves on the ABA Working Group on Investment Treaties. Howse has published widely, including *The Regulation of International Trade* (5th edition, 2020), and has held visiting positions at institutions such as Harvard Law School, LSE, Tel Aviv University, the Hebrew University of Jerusalem, and Osgoode Hall Law School.

Glenn Hubbard, *Professor of Economics, Columbia Business School and Department of Economics, Arts and Sciences*

Glenn Hubbard is a specialist in public economics, corporate finance, and financial markets. He has authored over 100 articles and books, including *The Wall and the Bridge*, and coauthored *Balance*, *The Aid Trap*, and *Healthy, Wealthy, and Wise*. Hubbard has applied his research in academia, business, and government, serving as Chair of the U.S. Council of Economic Advisers, Deputy Assistant Secretary of the U.S. Treasury, and Chair of the OECD Economic Policy Committee. He is co-chair of the Committee on Capital Markets and Regulation and past chair of the Economic Club of New York.

Rob Johnson, *President, Institute for New Economic Thinking (INET)*

Rob Johnson is President of the Institute for New Economic Thinking (INET), which he co-founded in 2009. He leads initiatives such as the Commission on Global Economic Transformation and the Young Scholars Initiative, and hosts the podcast *Economics and Beyond with Rob Johnson*. Previously, he was a Managing Director at Soros Fund Management and Chief Economist of the U.S. Senate Banking Committee. He has also served on the UN Commission of Experts on International Monetary Reform, produced documentary films, and holds a Ph.D. in Economics from Princeton University.

Ravi Kanbur, *Professor, Cornell University*

Ravi Kanbur researches development economics, public economics, and economic theory, and is known for his policy work in international development. He has served on the senior staff of the World Bank, including as Chief Economist for Africa, and published widely in leading economics journals. Kanbur has held leadership roles in numerous global initiatives, including Co-Chair of the Food System Economics Commission, Chair of the UN University-World Institute for Development Economics Research, President of the Human Development and Capability Association, and member of the OECD High Level Expert Group on the Measurement of Economic Performance.

David Kennedy, *Professor of Law, Harvard Law School*

David Kennedy is Manley O. Hudson Professor of Law and Faculty Director of the Institute for Global Law and Policy at Harvard Law School. He teaches international law, economic policy, legal theory, law and development, and European law. Kennedy's research draws on sociology, economics, and history to explore global governance, development, and professional expertise. He has worked internationally as a lawyer and consultant, including with the UN, EU, PricewaterhouseCoopers, and Cleary, Gottlieb, Steen & Hamilton, and served as Foreign Advisor to Thailand's Truth for Reconciliation Commission. He has held visiting professorships worldwide and served as Vice President for International Affairs at Brown University.

Richard Kozul-Wright, *Professor of Sustainable Structural Transformation, SOAS*

Richard Kozul-Wright spent over 30 years at the United Nations, including as Director of the Globalisation and Development Strategies Division at UNCTAD, overseeing the annual *Trade and Development Report*. He holds a PhD in economics from Cambridge University and has published widely in journals and books, including *The Oxford Handbook on Industrial Policy*, *The Case for a New Bretton Woods* (with Kevin Gallagher), and *The Resistible Rise of Market Fundamentalism*. Kozul-Wright is also a frequent contributor to international media, including *Financial Times*, *The Guardian*, and *Le Monde*.

Branko Milanović, *Professor, City University of New York (CUNY)*

Branko Milanović is a senior scholar at the Stone Center on Socio-Economic Inequality. He earned his PhD in economics from the University of Belgrade and worked for nearly 20 years as a lead economist at the World Bank. Milanović has taught at Johns Hopkins University and the University of Maryland. His research focuses on global and historical income inequality, including pre-industrial societies and contemporary globalization. His

Christian Moser, *Associate Professor, Columbia Business School*

Christian Moser is the Sidney Taurel Associate Professor of Business at Columbia Business School and an affiliated faculty member in the Department of Economics at Columbia University. He is a Faculty Research Fellow at NBER, a Research Affiliate at CEPR, and a Research Fellow at IZA.

Binaifer Nowrojee, *President, Open Society Foundations*

Binaifer Nowrojee is President of the Open Society Foundations. An international human rights lawyer, she has led regional programs in Asia-Pacific and East Africa and previously worked at Human Rights Watch investigating sexual violence during the Rwandan genocide. She has served as a lecturer at Harvard Law School and a fellow at Harvard's Carr Center for Human Rights. Nowrojee holds a JD from Columbia Law School and an LLM from Harvard Law School.

José Antonio Ocampo, *Professor, Columbia University SIPA*

José Antonio Ocampo is Co-Director of the Economic and Political Development Concentration at Columbia University's SIPA, a member of the Committee on Global Thought, and of the Initiative for Policy Dialogue. He previously served in senior positions at the UN and the Government of Colombia, including UN Under-Secretary General for Economic and Social Affairs, ECLAC Executive Secretary, Minister of Finance, and Minister of Agriculture. He has also chaired the Independent Commission for the Reform of International Corporate Taxation and numerous UN advisory committees. Ocampo holds a BA from the University of Notre Dame and a PhD from Yale University.

Ebrahim Patel, *Former Minister of Trade and Industry of South Africa*

Ebrahim Patel is the former Minister of Trade and Industry of South Africa, appointed in May 2019, and previously served as Minister of Economic Development. He has a long history of involvement in anti-apartheid and labor movements, including leadership of the Southern African Clothing and Textile Workers Union and participation in drafting key labor laws. Patel has served on the governing body of the ILO for a decade and contributed to the ILO's Declaration on Social Justice for a Fair Globalisation. He studied at the University of the Western Cape and University of Cape Town.

Andrea Prat, *Professor of Business, Columbia Business School*

Prat's research focuses on organizational economics and political economy, studying corporate leadership, employee motivation, and media influence on democracy. He is editor-in-chief of the *Journal of Law, Economics, and Organization* and a Fellow of the British Academy and Econometric Society.

Maria João Rodrigues, *President, Foundation for European Progressive Studies*

Maria João Rodrigues, former Portuguese Minister of Employment, is President of the Foundation for European Progressive Studies (FEPS) and a European politician with extensive experience in EU institutions, including the European Parliament, European Commission, and Council. She has contributed to major initiatives such as the Lisbon Treaty, Europe 2020 Strategy, Eurozone reform, and European responses to COVID-19. Rodrigues was a full professor of European economic policies and has authored over 100 publications and delivered more than 1,000 keynote speeches. She is a member of the Club of Rome and chairs the Advisory Board of the think-tank Re-Imagine Europa.

Jesse Schreger, *Associate Professor, Columbia Business School*

Jesse Schreger is Associate Professor in the Economics Division at Columbia Business School and co-director of the Global Capital Allocation Project. He is a Research Associate at NBER, a Research Fellow at CEPR, a Sloan Research Fellow, and co-editor of the *Journal of International Economics*.

Brad Setser, *Senior Fellow, Council on Foreign Relations*

Brad W. Setser is the Whitney Shepardson Senior Fellow at the Council on Foreign Relations, specializing in global trade, capital flows, and sovereign debt restructuring. He previously served as Senior Advisor to the U.S. Trade Representative and Deputy Assistant Secretary for International Economic Analysis at the U.S. Treasury. Setser is the author of *Sovereign Wealth and Sovereign Power* and co-author of *Bailouts and Bail-ins*, with publications in *Foreign Affairs* and other journals. He holds degrees from Harvard, Sciences Po, and Oxford University.

Miguel Soto-Class, *Founder and Board Chair, Center for a New Economy (CNE)*

Miguel "Mike" Soto-Class is founder of the Center for a New Economy (CNE) in Puerto Rico, recognized as one of the Top Think-Tanks to Watch by the University of Pennsylvania. CNE provides policy advice to the U.S.

He serves on multiple advisory boards and holds a BA from Yale University and a JD from Vanderbilt University.

Shari Spiegel, *Director, Financing for Sustainable Development Office, UN-DESA*

Shari Spiegel is Chief of the Policy Analysis & Development Branch in the Financing for Development Office (FfDO) at the United Nations Department of Economic and Social Affairs. She previously served as Executive Director of the Initiative for Policy Dialogue at Columbia University. Spiegel has extensive private sector experience, including as Principal at New Holland Capital and Director of Fixed Income Emerging Markets at Lazard Asset Management. In the early 1990s, she co-founded and was CEO of Budapest Alapkezelő, Hungary's first domestic investment fund. She has also advised the Hungarian Central Bank, World Bank, and IFC, and holds a BA in economics and applied mathematics from Northwestern University and an MA (ABD) in economics from Princeton University.

Joseph Stiglitz, *University Professor, Columbia University; Co-President, Initiative for Policy Dialogue*

Joseph E. Stiglitz is University Professor at Columbia University, co-chair of the OECD High-Level Expert Group on the Measurement of Economic Performance and Social Progress, and Chief Economist of the Roosevelt Institute. A Nobel Laureate in Economics (2001) and recipient of the John Bates Clark Medal (1979), he is a former Chief Economist of the World Bank and former Chair of the U.S. Council of Economic Advisers. Stiglitz founded the Initiative for Policy Dialogue at Columbia in 2000 and has authored numerous books, including *People, Power, and Profits*, *Rewriting the Rules of the European Economy*, and *Globalization and Its Discontents Revisited*. His work focuses on income distribution, corporate governance, public policy, macroeconomics, and globalization.

Marilou Uy, *Non-Resident Senior Fellow, Boston University Global Development Policy Center*

Marilou Uy is a Non-Resident Senior Fellow at the Global Economic Governance Initiative at Boston University and a member of the Independent High-Level Expert Group on Climate Finance, the IMF Task Force on Climate and Development, and the Jubilee Commission on Debt. From 2015 to 2023, she served as Director of the Secretariat of the Intergovernmental Group of Twenty-Four (G-24) on International Monetary Affairs and Development. She has also held senior management and advisory roles at the World Bank, leading its financial sector development practice globally.

Eric Verhoogen is Professor of International and Public Affairs and of Economics at Columbia University. His research focuses on industrial development, applied microeconomics, and the performance of firms in developing countries, intersecting development economics, international trade, and labor economics. He is co-director of the Center for Development Economics and Policy at Columbia and Research Program Director of the International Growth Centre. Verhoogen holds a PhD in economics from UC Berkeley, an MA from UMass Amherst, and an undergraduate degree from Harvard.

Lori Wallach, *Director, Rethink Trade Program at American Economic Liberties Project*

Lori Wallach is Director of the Rethink Trade program at the American Economic Liberties Project and Senior Advisor to the Citizens Trade Campaign, a U.S. national coalition of unions and advocacy groups. A 30-year veteran of U.S. and international trade policy, she has testified before 30 congressional committees and appeared as a trade commentator on numerous media outlets. Wallach is the author of *The Rise and Fall of Fast Track Trade Authority* and *Whose Trade Organization?*, and has been recognized for her leadership in trade debates and campaigns, including the Trans-Pacific Partnership. She holds degrees from Wellesley College and Harvard Law School.

Mark Weisbrot, *Co-Director, Center for Economic and Policy Research (CEPR)*

Mark Weisbrot is co-director of CEPR and holds a PhD in economics from the University of Michigan. He is author of *Failed: What the "Experts" Got Wrong About the Global Economy* and co-author of *Social Security: The Phony Crisis*. Weisbrot has published numerous research papers on economic policy and contributed opinion pieces to major media outlets including *The New York Times*, *The Washington Post*, and Brazil's *Folha de São Paulo*.

Keren Yarhi-Milo, *Dean, Columbia University SIPA*

Keren Yarhi-Milo is Dean of Columbia University's School of International and Public Affairs and Adlai E. Stevenson Professor of International Relations. A leading scholar on international security and crisis decision-making, her work explores foreign-policy decisions, leadership psychology, signaling, intelligence analysis, and diplomacy. Yarhi-Milo is the author of *Who Fights for Reputation?* and *Knowing the Adversary* and has published widely in top political science journals. She founded Columbia's Institute of Global Politics and co-taught *Inside the Situation Room* with Secretary Hillary Clinton. Yarhi-Milo holds a PhD from the University of Pennsylvania and a BA, summa cum laude, from Columbia University. She is a member of the Council on Foreign Relations.
